**NOTICE IS HEREBY GIVEN** that on Wednesday, August 16, 2006 at 7:00 p.m. (or as soon thereafter as possible) the City Council of the City of Aliso Viejo will conduct a public hearing to consider the following:

**Renovation of Athletic Field at St. Mary and All Angels School: The renovation of the athletic field, including the installation of artificial turf, the expansion of the field on the east side by approximately ten feet, the removal of approximately 60 trees along the north and east boundaries of the field, and the replacement of the existing six-foot high fence with ten foot high fencing on the north and east boundaries (plus additional ten-foot high netting on the north boundary). No field lighting is proposed.**
