NOTICE IS HEREBY GIVEN that on **Wednesday, October 19, 2005**, at **7:00 p.m.** (or as soon thereafter as possible) the City Council of the City of Aliso Viejo will conduct a public hearing to consider the following:

TENTATIVE TRACT MAP 16881, TO DIVIDE APPROXIMATELY 1.912 ACRES INTO 14 NUMBERED AND LETTERED LOTS FOR DEVELOPMENT OF RESIDENTIAL USES; AND SITE DEVELOPMENT PERMIT SDP05-10 TO DEVELOP 12 SINGLE-FAMILY RESIDENTIAL UNITS ON THE 1.912 ACRES TOGETHER WITH COMMON AREA LANDSCAPE AREAS. THE SUBJECT PROPERTY OF THESE REQUESTS IS LOCATED ON THE NORTHEAST CORNER OF EASTWING AND SKYLARK DRIVE, AND IS COMMONLY KNOWN AS VENTANA RIDGE.
