**NOTICE IS HEREBY GIVEN** that on Wednesday, October 19, 2005 at 7:00 p.m. (or as soon thereafter as possible) the City Council of the City of Aliso Viejo will conduct a public hearing to consider the following:

**ZETTLER BUILDING ADDITION: A SITE DEVELOPMENT PERMIT FOR A 17,290-SQ.FT. ADDITION TO AN EXISTING 48,000-SQ.FT. BUILDING. THE SITE IS AT 75 COLUMBIA, WITHIN THE PACIFIC PARK 1 BUSINESS PARK, WEST OF ALISO CREEK ROAD. IT IS BORDERED BY ALISO VIEJO PARKWAY ON THE SOUTH AND BY OTHER BUSINESS PARK USES ON THE REMAINING THREE SIDES. THE SITE CONTAINS 2.3 NET ACRES.**
